Jim Wiederholt Named Employee of the Third Quarter

Code Enforcement Officer, Jim Wiederholt has been selected as the Employee of the Quarter for the third quarter of 2011. The other nominee was Paul Read.

Jim began working for the City in 1991 as a part-time employee in the Public Works department and quickly transitioned into a full-time employee with the title of Assistant Code Enforcement Officer. In 1998 he was promoted to Code Enforcement Officer. His position requires him to be certified in several different areas to perform inspections of existing buildings and new construction.

Due to a number of structural issues within the City, Jim has been put in the precarious situation of having to see the buildings razed and/or repaired in the downtown. He has been effectively and efficiently staying on top of both the property

owners and insurance companies to see these projects through to completion. Making matters more stressful has been the recent hail storm in mid-August which has resulted in him being responsible for a significant number of inspections that he recommended be waived (associated with the storm) to help the community rebuild from the sustained damage.

The expectations and stresses associated with the destroyed buildings coupled with the damage to property from the storm have been great. Jim has still kept a level head about himself while still keeping on task and seeing the issues through to their completion. He has created the accountability to others (property owners and insurance companies) and also seen that the needs of the citizens have been met during this time of crisis for them individually.

Although these tasks are certainly within Jim's general scope of work, the volume of work and the expectations from the top down in the organization and in the community have been met in a timely and efficient manner – an accomplishment which deserves to be recognized. Having the knowledge and experience Jim possesses has made the process that much smoother and seamless.

Denise Town Named CPFO

Denise Town, finance director for the City, has received notification from the Government Finance Officers Association (GFOA) of her successful completion of its Certified Public Finance Officer program. This is a broad educational self-study program designed to verify knowledge in the disciplines of government finance. The Certification Program is governed by the Council on Certification. Technical and administrative support for the program is provided by Radford University's Governmental and Nonprofit Assistance Center.

To earn the designation of Certified Public Finance Officer (CPFO), candidates must pass a series of five examinations covering the major disciplines of public finance:

- Governmental Accounting,

Auditing and Financial Reporting

- Cash Management and Investments
- Debt Management
- Operating and Capital Budgeting
- Pension and Benefits, Risk Management and Procurement

Candidates are allowed 3 ½ hours to complete each exam, which consists of 175 multiple choice questions. A candidate has seven years in which to successfully complete the program; exams are offered three times a year. Once earned, the CPFO designation is maintained by participating in 30 hours of continuing professional education each year.

A candidate must meet the following two eligibility require-

ments in order to take the certification exams:

Education: A candidate must have, at a minimum, a baccalaureate degree from an accredited institution.

Ethics: A candidate must accept and observe the GFOA Code of Professional Ethics.

Once all five examinations have been successfully completed, a candidate must meet 3 additional requirements relating to government employment and GFOA membership to be designated a CPFO.
