Each boat participating in the fishing tournament must obtain and display an appropriate Mozingo Lake Access Permit sticker.
- B. The aforementioned applicant and his party hereby agree to comply with the Park rules and regulations and all applicable statutes and ordinances governing the Mozingo Lake Park facilities.
- C. The applicant further agrees that the City of Maryville shall have the authority to revoke a fishing Tournament Permit upon reason to believe there has been a violation of any park rules or ordinance or law or upon good cause shown.

- D. The applicant hereby agrees that, if the Fishing Tournament Permit is granted, it shall be granted only for the event as specifically detailed within the permit application. Any alteration or deviation from the event as described shall authorize the City to immediately terminate the Fishing Tournament Permit and the closing of the facility to the participants.
- E. Applicant agrees to apply for and obtain all required permits or licenses necessary for the special event as described within this permit.
- F. Applicant further agrees to furnish the City of Maryville any additional information which it deems necessary to properly review this Fishing Tournament Permit Application.
- G. I/WE agree to indemnify and hold harmless the City of Maryville, its staff and officers.
- H. I/WE agree to abide by all park rules.
