**Mozingo Lake Recreation Park & SNAG**

Kyle Easter and Erick Auxier recently attended training for the SNAG® (Starting New at Golf) program. SNAG® is a proven player development program designed for new learners of all ages. SNAG® contains all the elements of golf but in a modified form, making it an easy and fun way to learn and play golf. The system builds on strong fundamentals of putting, chipping, pitching and full swing to develop playing ability quickly and effectively. SNAG® incorporates developmentally appropriate equipment and instruction that will allow golf to be learned and played in non-traditional venues, such as on a soccer field, in a gym, or on the beach. The game has its own simplified rules and terminology that adds fun to the learning and playing experience. In cooperation with Northwest Missouri State University, the SNAG® program will be implemented into the school districts (elementary, middle, and high school) of Maryville, West Nodaway, North Nodaway, Worth, Northeast Nodaway, Nodaway Holt, Stanberry, South Nodaway, and Jefferson. Mozingo Lake Recreation Park Golf Course will also implement this program for the current Junior Golf program. As Kyle Easter is a member of the Midwest PGA section, he will be the Task Force Manager for Nodaway County in the SNAG® program. Kyle will be assisting all teachers and coaches to integrate the SNAG® program into their schools. This program will facilitate growth of the game in this section of the state and serve to make Mozingo the “home course” for the surrounding areas.



### Phase 1, Munn Avenue Trail STP-4300(108)

All easements necessary to construct the Phase I, Munn Avenue Trail have been acquired and a letter has been sent to the Missouri Department of Transportation (MoDOT) for Right-of-Way Clearance Certification. The requested clearance will allow the project to be bid to construction contractors for a tentative April-May start date. The project constructs a six (6) foot wide concrete trail along Munn Avenue approximately 1,900 linear north feet from South Avenue to Victory Lane. The project is 74.2% funded by MoDOT Transportation Enhancement (TE) funds which were awarded in 2008. Originally this trail segment was planned for Walnut Street from South Avenue to Lincoln, however it was met with opposition from property owners and created a dangerous pedestrian crossing along South Avenue where sign distance is limited. The new alignment has been well received, improves sight distance at South Avenue, and connects directly to the trail segment on the Munn Avenue Project (South Avenue to Highway V).

### 2012 International Building Codes (IBC) Update

The International Code Council (ICC) held an all-day 2006 IBC to 2012 IBC transition seminar in Little Rock, Arkansas on January 15th. The seminar assisted participants in implementing the transition and included interactive training with the opportunity for professionals to discuss and consider changes. Significant differences between the two versions were discussed along with the applicability of design, plan review, and inspection requirements. Code Enforcement Officer Jim Wiederholt attended this seminar on behalf of the City of Maryville and returned with valuable information regarding the implementation. Mr. Wiederholt has also completed a training entitled Analysis of Changes to 2011 NEC (National Electric Code). Other online trainings have included updates to building, mechanical, fire, plumbing and residential codes. All new code books have been ordered and are available for public review. Meetings regarding proposed changes are underway for various specific trades such as electricians and plumbers. On February 3, 2014, a ninety (90) day public review period began as mandated by the state statutes. A letter was sent to all licensed contractors notifying them of this review period and further public notices are planned.



### Maryville Public Arts Coalition (MPAC) Advisory Board Meeting

On January 27th, the City Council approved a Municipal Code change to officially create the Public Art Advisory Committee. The group is designated to advise staff and City Council on all matters of public art within the community and more specifically to manage the SculptureOne Program for temporary art located in downtown. The committee held their first meeting since being incorporated on Thursday, February 13th at 6:30 p.m. in the Chamber of Commerce conference room. The meeting allowed the group to elect officers, discuss official business, and obtain general information about public meetings/board responsibilities from City Clerk, Sheila Smail. ### Public Works Water/Sewer Maintenance

The Public Works Water/Sewer Maintenance Division has been working around the clock to combat several water main leaks and frozen meters since the first of the year. Bitterly cold weather and snow has created a total of seventy-seven (77) frozen meters and ten (10) water main leaks. Over sixty-two (62) hours have been spent on water leaks alone in the last several weeks. Crews continue to battle the weather and are performing exceptionally to ensure service is provided without extended interruptions.



### Public Works Street Maintenance

The Public Works Street Maintenance Division has spent numerous hours performing ice and snow removal from City streets throughout the winter months. The most recent 5" of snow had crews out for approximately twelve (12) hours of additional overtime. All emergency routes were treated and plowed before moving on to residential and parking lots. The City still has approximately 150 tons of salt supply to address future storms. Salt prices across the region have drastically increased from \$60/ton to \$135/ton this season due to availability. A typical minor snow event requires 20-30 tons of salt and ice requires slightly more. Crews will continue to analyze need and weather patterns before purchasing more salt this season.
