On Friday, August 22nd, Kawasaki Motors held a 25th anniversary celebration for operation of the Maryville plant. The ceremony was well attended by overseas Kawasaki leadership, strategic business partners, and community leaders. Mayor Renee Riedel spoke on behalf of the community showing our appreciation for all the company brings to Maryville. The community also presented a die-cut metal plaque matching the ceremony invitation design. President Matt Kurushima and Vice President Steve Bratt led the event which featured a ceremony, tour of the facility, luncheon, and a kagami biraki ceremony where a wooden cask of sake is ceremoniously opened with a mallet. The Maryville engine plant opened in 1989 and has expanded eleven (11) times to house over 800 employees under the 796,699 square feet of building.

MLRP Recreational Trails Program (RTP) Grant



MISSOURI DEPARTMENT OF NATURAL RESOURCES

The City of Maryville has been awarded the 2014 Recreational Trails Program (RTP) Grant. The RTP Grant is for \$100,000 with a matching city portion of approximately \$28,500 in materials and in-kind labor. The award marks the second \$100,000 RTP Grant that the City has been awarded within the past two (2) years for trail development at Mozingo. Construction is ongoing for the trail project of the 2013 RTP award and trail construction for the 2014 RTP Grant is anticipated to begin in 2015. Staff will be utilizing the approved Mozingo Master Plan as guidance when determining the final trail location.

MLRP Land Water Conservation Fund Boat Dock Grant



The City of Maryville has been awarded the 2013 Land Water Conservation Fund (LWCF) Grant to purchase a twelve (12) slip boat dock to be placed at the RV Park. The new boat dock will be eco-friendly, being made of recycled materials and will be ready for use in the Spring of 2015.

4th Street Improvement Project, Phase 1, STP-4303 (101)



Construction is underway on the 4th Street Improvement Project, Phase I. Orr Wyatt Streetscapes has been at work reconfiguring the Dunn and 4th Street intersection. The existing intersection has been demolished and curbs along the reconfigured alignment have been poured. A new concrete base has been poured at the intersection and the installation of the waterline is nearly complete. Once complete, the contractor will continue working east along the north side with trail demolition and construction. The City continues to work closely with Northwest Missouri State University for proper notifications and scheduling on the project.

Tom Watson Reviews Jr. Golf Course Construction

On Monday, August 18th, legendary golfer Tom Watson visited the construction site of the Tom Watson designed Jr. Golf Course at Mozingo Lake Recreation Park. Mr. Watson met with the contractor Mid-AmericaGolf & Landscape, Inc. to review course elevations and contour changes. While onsite, Mr. Watson also met with members of the Junior Golf Course Committee, City Staff, and Orval Heywood to express gratitude for his financial support of the new pitching and putting area. Construction of the course by Mid-AmericaGolf & Landscape began in July and rough grading is approximately ninety percent (90%) complete. Substantial completion should be reached in October with the course playable in the spring of 2015. The nine (9) hole short course is designed in partnership with the Tom Watson Golf Course Design Group, Inc. and will serve for generations as a vehicle for junior golf instructional programs.
