#### The Answer:

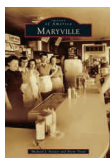
The Brenker Brothers Bakery Shop was the name of the first soda fountain.

**Wells Bank to Construct  
New Bank in Maryville**

Wells Bank of Platte City is pleased to announce that it has filed an application to construct a new banking facility in Maryville. Wells Bank has now been partnering with the City of Maryville to facilitate the project for the last several months. The new facility will be located at 2920 South Main Street directly across from Applebee's restaurant. The 3,400 square foot building will have three drive through lanes, one with ATM access. It will be staffed to offer a full line of personal and business deposit and loan accounts, including fixed rate mortgages for residential and agricultural real estate.

Wells Bank is a \$120 million bank headquartered in Platte City with a branch office in Kansas City. The bank has several officers with local ties to Nodaway County including their President and Chief Executive Officer Robert Barmann who spent 20 year sat Bank Midwest. Other officers from the are include Executive Vice President and Chief Operating Officer Brad Meyer, Senior Vice President and Loan Officer Joe Carroll, Vice President and Compliance Officer Stephanie (Heitman) Walker and Assistant Vice President and Loan Processing Manager Eric Henry.

"Wells Bank is a true community bank that has served the Platte City community for over 100 years. Every decision we make has a community banking influence which we believe gives us an advantage in today's banking landscape" said Robert barman.

According to City Manager Greg McDanel, "Wells Bank is anticipated to become the anchor to a 25 acre development that will include additional retail and housing. The City Council approved a Development Agreement regarding public infrastructure to the site at the January 26th council meeting.

The new Maryville facility is scheduled to open for business in the fourth quarter of 2015.

**StormReady City Renewal**

The National Weather Service in Kansas City/Pleasant Hill has renewed Maryville's designation as a StormReady City. By maintaining the StormReady status, Maryville has demonstrated its commitment toward planning for hazardous weather. The recertification marks the 2nd successful recertification effort since the original designation in 2007. In 2007, Maryville was one of five designated communities in the state. The recertification process was managed by Jessica Sigman, Dispatch Supervisor for the Maryville Public Safety Department. StormReady requirements include an established 24-hr EOC (Emergency Operations Center), proper release of National Weather Service Warnings, Hydrometeorological Monitoring, Community Preparedness, and adopted administrative documents. Maryville Public Safety will be presenting the Local Emergency Operations Plan (LEOP) in February to the City Council to refresh council/staff roles and responsibilities in an emergency.

**Kawasaki Completes Tax Credit Need for  
4th Street Improvement Project**

Kawasaki Motors Manufacturing Corp., U.S.A., has agreed to purchase up to \$200,000 in Neighborhood Assistance Program (NAP) tax credits to contribute to the 4th Street Improvement Project, Phase I. The 70% Missouri State Tax Credits were made available through the Missouri Department of Economic Development's Neighborhood Assistance Program to assist with ancillary construction features of the project. The 4th Street Improvement Project is designed to functionally and aesthetically improve the corridor between downtown Maryville and the campus of Northwest Missouri State University.

The significant contribution by Kawasaki completes sale of available tax credits and ensures adequate funding for completion of the project. Total contributions in the amount of \$483,000 were secured during the tax credit revitalization effort by Nodaway County Economic Development (NCED) and the City of Maryville. The City expresses appreciation to Kawasaki for their partnership and all individual donors during the process.



**Rip Rap Project at  
Mozingo Lake Recreation Park**

Staff has substantially completed the first phase of the shoreline stabilization rip rap project. As of now, rip rap has been placed along the shore for the majority of the area from the beach area extending north to the City boat ramp. Staff has worked in partnership with Tory Mason from the Missouri Department of Conservation on this project. Surplus material remains from the initial \$60,000 purchase and this material will be used in several different areas. Mozingo and MDC staff have identified additional high priority shore stabilization areas around "The Point" and will be completing that project within the next couple of weeks. Additional rip rap has also been used to create a breakwater jetty on the north side of the beach to reduce beach and shoreline erosion. Finally, the remaining material will be used to prepare for the new dock at the RV campground by extending a walkway pier and creating a new dock pier at family cabins 6, 7, and 8.
